The Consumer Accounts with UMR mobile application lets you easily and securely access your accounts, submit claims and upload receipts at any time. You have quick access to common tasks with an easy-to-use design that helps make sense of your health and financial information.

### Stay up to speed

The Consumer Accounts with UMR app can get you to the account information you need – fast. Wondering whether you have enough money to pay a bill or make a purchase? UMR puts the answers at your fingertips.

- Check account alerts
- View claims requiring receipts
- Log in with face ID authentication
- View charts summarizing account information
- Quickly check available balances and account details for Consumer Account\$
- Find links to an external web page to obtain helpful information, such as a list of eligible expenses, if applicable to your plan
- Use your device of choice – including iPhone®, iPad®, iPod touch® and Android™ smartphones and tablet devices



### Get started with the Consumer Accounts with UMR app

- 1 Begin by downloading the Consumer Accounts with UMR mobile app from the Apple App Store or Google Play.
- 2 If you are a new mobile app user, select “**New User? Set up your account**” to register.
- 3 If you have already viewed your account through umr.com and don't remember your separate mobile app username and password, select “**Forgot password?**”

- Enter and view expense information and receipts
- Report a debit card as lost or stolen, if applicable
